Minimum Qualifications for Visiting Lecturer

1. Lecturer in Automobile Engg.

- i) Bachelors and Masters of Engineering or Technology degree in Automobile with First Class either in Bachelors or Master's degree from a recognized University / Institution.
- ii) Bachelors of Engineering or Technology degree in Mechanical with Automobile Engineering as one of the subject and Masters of Engineering or Technology degree in Automobile with First Class either in Bachelors or Master's degree from a recognized University/Institution; and Hindi or Sanskrit as one of the subject in Matric or Higher Education.

2. Lecturer in Electronics and Communication Engg.

- (i) Bachelors and Masters of Engineering or Technology degree in Electronics and Communication Engineering or Electronics Engineering with First Class either in Bachelors or Master's degree from a recognized University/ Institution; and
- (ii) Hindi or Sanskrit as one of the subject in Matric or Higher Education.

3. Lecturer in Instrumentation & Control Engineering

- (i) Bachelors and Masters of Engineering or Technology degree in Instrumentation & Control Engineering/ Electronics and Instrumentation Electronics/ Applied Electronics and Instrumentation Engineering with First Class either in Bachelors or Master's degree from a recognized University/Institution; and
- (ii) Hindi or Sanskrit as one of the subject in Matric or Higher Education.

Minimum Qualification For Visiting Workshop Instructor

1. Workshop Instructor

- (i) Matric or its equivalent;
- (ii) Industrial Training Institute Certificate or its equivalent in the trade with at least 60% marks (the relevant trade to be indicated at the time of recruitment).
- (iii) Hindi up to Matric Standard.
- (iv) Craft Instructor Training Course in respective trade or two years' experience in trade after attaining the basic qualifications.

The practical experience should be in a recognized institute (Recognized by All India Council for Technical Education or Government of India or in & Public Limited Company);

OR

- (i) Matric or equivalent;
- (ii) Diploma in Engineering in relevant trade from Recognized Institute or Poly-technic awarded by State Board Technical Education with at least 60% marks and Craft Instructor Training Course passed and experienced Candidate will be preferred;
- (iii) Hindi up to Matric Standard.
